Resolution : The Academic Council resolved to approve and ratify the structure, scheme and syllabi of all the programmes with the following suggestions

## **General Suggestions**

- A common scheme and structure with LOCF pattern of Curriculum Framework can be followed by all the departments..
- A uniform credit distribution to all core courses may be followed.

## **Department-wise suggestions History**

UG:

- In Semester VI, the title of the Ability Enhancement Course III- "Hotel Management" can be changed as "Tourism and Hotel Management".
- A new Allied course can be introduced instead of " Public Administration" in Semester IV.

PG:

- In Semester III, the title of the core course CCIX " Contemporary Tamilnadu since 1947" must be changed as "Tamilnadu since 1947 C.E".
- In Semester IV, the title of the course EC III "Contemporary Science and Technology" has to be changed as "History of Science and Technology"

### **Economics**

In Semester V, the titles of the courses "Capital Marketing" and "Human Resource Management" have to be changed as "Capital Market" and "Human Resource Development" respectively.

#### **Commerce**

UG: In Allied course I Business Mathematics and Statistics, the title of Unit III can be "Average and Measures of Dispersion" instead of "Business Statistics and Measures of Central Tendency" .

PG: In Semester IV, the Elective course, "EC III Security Analysis" and the core course "CCXII- Teaching and Learning Skill" can be interchanged.

For 2023-24 batch, modifications made in the content of the core course VII "Income Tax Law and Practice" and it was approved by the members of Academic Council.

#### **Mathematics**

In Semester V & VI, "R lab with Tableau" must be given as Extra Credit Course.

For PG degree programme, it is suggested to offer "Mathematics for CSIR NET/SET/ TRB/ Competitive Examinations coaching" in semester II instead of semester IV.

## Chemistry

For I B.Sc Chemistry, instead of Allied Zoology course, Allied Biology Course can be introduced.

## Zoology

In M.Sc Zoology, the title of the Industry Based Course "Applied Biotechnology" has to be changed as "Animal Biotechnology" in Semester III.

### **Physics**

The syllabi presented was approved and ratified.

## **Botany**

The Academic Council members suggested to resubmit the scheme and structure after consulting the Board of Studies members in a week time. Academic Council expert Dr.P.Maraippan suggested to introduce Green audit course for the final year students.

#### Tamil

- In semester III , it is suggested to include "Villibharatham" as Unit V in the core course "Kaappiyam".
- The elective course "Ilakkiyathil Melaanmai" can be offered in semester VI instead of the elective course "Nirvaahaviyal".

## **English**

- The title of the Core Course VII "Aspects of Language and Linguistics" has to be changed as "Introduction to Language and Linguistics"
- The author names T.S.Eliot and Rabindranath Tagore must be added in the title of the Core course IX "Authors in Focus"
- The Title of the Core Course XIII "Shakespeare Studies" has to be changed as "Shakespeare".
- In core course XIV "Post Colonial Literature in English", replace the existing writers Maya Angelou and Girish Karnard with Gabriel Okara, Chinua Achebe and Vijay Tendulkar in the Units II & IV
- The title of the Discipline Specific Elective "Mass Communication and Journalism" has to be changed as "Introduction to Mass Communication and Journalism"
- Practical components must be added to the Skill Enhancement course II "English for Career".

HOD of English was advised to contact the University Nominee Dr. V. Vinod Kumar for approval.

## **Biochemistry**

- In Semester IV, instead of "NME II-Cosmetology" a biochemistry based course can be offered.
- it is suggested that DSE III Research methodology course is not necessary in UG level and advised to introduce a suitable course in the place of research methodology.
- The title of the course " Certificate Course in Tools and Techniques in Bioscience" can be changed as "Tools and Techniques in Bioscience"

### **BBA**

- In the Course MCII- "Business Mathematics and Statistics" ,
   Mathematics contents have to be included in Units I and II.
- The percentage of Theory and problem part should be mentioned in the courses like Management Accounting, Financial Accounting, Operations Research and Cost Accounting.

## **Computer Science**

The title of the Skill Enhancement Course "PC package lab" should be changed as "Computational Skill Lab" in Semester I.

The "Ability Enhancement Course - IoT lab" can be moved from semester V to VI. More number of lab exercises can be given.

#### **BCA**

The title of the "Multi Disciplinary Course - PC package lab" can be changed as "Computational Skill lab" in Semester III.

#### **Information Technology**

The title of the Skill Enhancement Course "PC package lab and Internet Lab" can be "Computational Skill and Internet Lab" in Semester I.

#### Geology

The council advised to consider a tie-up with ONGC to leverage their expertise in Oil and gas exploration and production. Such collaborations would enable students to gain practical experience, enhance their skills and to increase employability.
